### Abstract:

The current study assesses how customers feel about the NPCI-created Unified Payment Interface, which enables users instantly transfer money and conduct cashless transactions around the clock. Only when users are fully informed of UPI features, operations, and safety guidelines will their use be beneficial. The main reason for conducting this study is to assess the degree of customer awareness of UPI applications based on demographic variables, the causes of UPI frauds, the various types of UPI applications that are frequently used by customers, and to determine the extensive usage of UPI applications among customers. The field survey was used to gather primary data from 100 randomly selected respondents. The hypothesis has been tested using the Chi-Square test. The results show that none of the respondents are completely unaware of the Unified Payment Interface application, while 15% of respondents are highly aware, 61% have a moderate level of awareness, 20% have a low awareness level, and 15% have a very low awareness level.

## ABSTRACT

Alarming shoots up in the field of technology and communication raise the interest of researchers towards materials to reduce electromagnetic (EM) pollution. In this view, mesoporous  $\text{La}_{0.5}\text{Sr}_{0.5}\text{Fe}_{0.5}\text{Mn}_{0.5}\text{O}_3$  (LSFMO) was synthesized by a dual impregnation process using SBA-15 as a template. The LSFMO was mixed with graphene oxide, which is synthesized using a modified Hummer's method in different weight ratios (1:0, 1:2, 1:1, 2:1, 3:1) to prepare composites by in-situ reduction of Graphene Oxide (GO). The structural properties were investigated using XRD, FE-SEM, FT-IR and nitrogen adsorption/desorption isotherm. The in-situ synthesis illustrates the growth of mesoporous LSFMO on the layers of reduced graphene oxide having an effective surface area of  $31.6 \text{ m}^2 \text{ g}^{-1}$ . The composite  $\text{La}_{0.5}\text{Sr}_{0.5}\text{Fe}_{0.5}\text{Mn}_{0.5}\text{O}_3$ -RGO (LSFMG31) showed good electrical conductivity of  $53.66 \text{ S/m}$  with high shielding effectiveness (SE) of  $57.63 \text{ dB}$  ( $\sim 99.999\%$  of attenuation of electromagnetic waves) in Ku-band ranges from  $12.4\text{--}18 \text{ GHz}$  at  $2.85 \text{ mm}$  thickness. The shielding effectiveness is mainly dominated by absorption, which may be further utilized for commercial applications.

## 1. Introduction

Electromagnetic Interference (EMI) is radiation pollution in the air/environment. EMI has become a major problem because of the escalation of defense, electronic and scientific electrical devices. These devices must be guarded against incoming and potentially disturbing radiation and restrict the outgoing radiation flow [1,2]. Electromagnetic shielding materials are fabricated and developed to minimize the EMI adverse effects on the instruments and human health [2]. Over the past few decades, scientists and researchers have testified to various research exploring the properties, synthesis techniques, fabrication and application-based work in the field of electromagnetic shielding nanomaterials [3–5]. Microwave absorption is an emerging area because of the technological advancement in electronic devices, radars and telecommunication systems. The synthesis of microwave absorption material with tunable application-based properties remains a great challenge. The material that effectively absorbs the radiations should have good thermal stability, strong absorption, broad bandwidth, lightweight, ease of synthesis, and modulating electronic properties, etc. To accomplish the aforementioned properties of microwave absorption materials (MAM's), extensive research has been devoted from conventional metals

to novel composite materials. For MAM's, the material should possess high electrical conductivity and high permeability, hence magnetic materials are preferred [6–8].

Metals [1] and ferrite-based [9] products were conventionally used as radiation-shielding materials. Liu et al. [10] synthesized ZnO nanocapsules coated Fe using the arc discharge method and observed the reflection loss (RL) of  $-57.1 \text{ dB}$  in  $2\text{--}18 \text{ GHz}$  frequency band with  $3 \text{ mm}$  absorber thickness, reporting that this absorption is the outcome of impedance matching and strong natural resonance. Li et al. discussed the nano-casting strategy of synthesis of  $\text{CoFe}_2\text{O}_4$  using SBA-15 via the two-solvent method. It was reported that a minimum RL of  $-18 \text{ dB}$  at a thickness of  $2 \text{ mm}$  and broad  $4.5 \text{ GHz}$  bandwidth in the frequency range  $2\text{--}18 \text{ GHz}$  [11]. Zhao et al. [12] studied the shielding for dendrite and rodlike NiCu alloy synthesized via a one-pot hydrothermal process and reported a reflection loss of  $-31.13 \text{ dB}$  with  $1.5 \text{ mm}$  thickness. The absorption results are ascribed to space-charge polarization due to the heterostructure of Ni-Cu alloy and interfacial polarization between paraffin wax and synthesized alloy. Some mixed oxide metals like  $\text{SiO}_2$ ,  $\text{TiO}_2$  are also used as reported by Liu et al. [13]. They synthesized the novel composite of Co Ni with  $\text{SiO}_2$ ,  $\text{SiO}_2\text{-TiO}_2$ , and  $\text{Alr-TiO}_2$ , i.e., the as-synthesized composites showed better impedance matching
